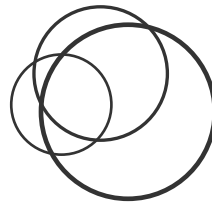

DEFERRED GIFTS

In general terms, most donors make a *present gift*, meaning Hospice Calgary receives the donation immediately.

For a *deferred gift*, the donor creates the gift now and Hospice Calgary receives the benefit of the gift at a later time (e.g. upon the donor's death or at a specified time).

Deferred gifts may include:

- Bequests in a Will
- Life Insurance (proceeds)
- Gifts of RRSPs or RRIFs
- Charitable Remainder Trusts

While there are various ways to arrange a planned gift, the key is to ensure that your gift works within your overall estate plan. For instance, if you would like your gift to be used for a specific purpose, we ask that you contact us to discuss your wishes before finalizing your will.

We hope you will consider a planned giving option in support of Hospice Calgary. In the continuum of care, we are here for the entire journey, helping individuals and families find support, compassion, and hope before and beyond bereavement.
